YOU MUST FILE A SALES TAX ADJUSTMENT FORM WHENEVER YOU SHIP OR DELIVER PRODUCTS TO A DIFFERENT TAXING LOCALITY AND/OR YOU SELL AT A DIFFERENT AMOUNT THAN SUGGESTED RETAIL.

This corporation has agreements with all states (except Alaska) and various counties and cities which impose a sales tax to collect these taxes on behalf of independent business owners. Under the terms of these agreements, tax is to be collected based on the suggested retail price of the taxable products and the sales tax rate for the zip code of the first ship-to address.

Exception -CUSTOMER CREDIT CARD ORDERS

On orders that are billed to a customer's credit card, sales tax will be charged on the actual selling price. You must state your actual selling price when placing an order that will be billed to a customer's credit card. This information will be used solely to properly process the credit card order and to make accurate reports for sales and tax purposes.

On orders that are billed to an independent business owner's credit card, sales tax will be charged on the suggested retail price.

As an independent business owner, you agree to be bound by these agreements and all related rules and procedures established by the corporation.

As an independent business owner, you are responsible for the proper application of sales tax on all your sales. If you follow the procedures set forth below, the proper sales tax will be paid. If you do not collect the identical sales tax (same jurisdiction and amount) as was originally paid with your order, you are to complete and submit the "Sales Tax Adjustment Form" to the Sales Tax Department.

The basic rule to be followed in determining the correct sales tax to be charged on RETAIL SALES is: **collect the sales tax based on your selling price of taxable products, using the applicable sales tax rate for the taxing jurisdiction in which the retail customer takes possession of the products.**

The basic rule to be followed in determining the correct sales tax to be charged on SALES TO ANOTHER INDEPENDENT BUSINESS OWNER is: **collect the sales tax on the suggested retail price of taxable products, using the applicable sales tax rate for the taxing jurisdiction in which the independent business owner takes possession of the products.**

There are several circumstances under which you will not collect the identical sales tax you paid and, therefore, must submit a Sales Tax Adjustment Form:

Note: Do not include shipping charges or the sales tax paid on shipping, on the sales tax adjustment form.

1. Sales made into another State

When shipping or delivering products to another state, you must collect the applicable sales tax for the state of destination. Since tax rates and taxability of products vary by state, the Sales Tax Department will supply you with a listing of tax rates and exempt products for all states upon request.

• **If you sold at a higher or lower rate:** Send only the difference of the tax collected for the higher rate in the form of a check payable to Sales Tax Dept. along with an Adjustment Form. Please indicate on the form the amount(s) and local jurisdiction(s) for which the tax was collected. If you collect a lower rate, the Sales Tax Dept. will refund the difference of the sales tax.

If you are making sales to a retail customer or another independent business owner who resides in another state, but who is picking up the products at your location, you must collect the sales tax that applies at **your** location.

Please Note: Always remember that the tax charged will reflect the tax which applies to the zip code of the first ship-to address.

2. Sales in the Same State, but at a Different Rate of Sales Tax

Many states have local taxes in addition to the state's sales tax. When shipping or delivering products within your own state, you must collect the sales tax that applies where the purchaser receives the products. If you ship or deliver products in a taxing jurisdiction other than the one in which you purchased, you must file a Sales Tax Adjustment form with the Sales Tax Department as to the locality (city and county) in which you sold the products and the total rate of tax collected. Use section two of the adjustment Form to make this required notification.

- **If the local sales tax collected is at the same rate for different jurisdictions:** You must report the local tax adjustment to the Sales Tax Department so that the necessary adjustments are made to ensure that each local jurisdiction receives the proper tax.

- **If you sold at a higher or lower rate:** Send only the difference of the tax collected for the higher rate in the form of a check payable to Sales Tax Dept. along with an Adjustment Form. Please indicate on the form the amount(s) and local jurisdiction(s) for which the tax was collected. If you collect a lower rate, Sales Tax Dept. will refund the difference of the sales tax.

3. Retail Sales Not at Suggested Retail Price.

When making sales at a price different than suggested retail, you must charge only the sales tax applicable to your selling price of the taxable products.

- **On sales made at a price lower than suggested retail:** Obtain a refund of the excess sales taxes paid by submitting the Adjustment Form with section four completed. The refund is the difference between the sales tax which was paid on the suggested retail price and the sales tax on the independent business owner's selling price. **(Do not include the delivery fee or the tax on the delivery fee).**

- **On sales made at a price higher than the suggested retail price:** Enclose a check payable to Sales Tax Department for the additional sales tax due. The additional sales tax due is the difference between the sales tax on your selling price and the sales tax paid on the suggested retail price. **(Do not include the delivery fee or the tax on the delivery fee).**

4. Products for Personal Use or Demonstrations

When you purchase products, you will pay sales tax based on the suggested retail price. If you use the products personally or for demonstrations, the basis for computing sales tax becomes "wholesale cost." You may obtain a refund of the difference between the sales tax paid on the suggested retail price and the sales tax on the wholesale cost by filing the Adjustment Form with section four completed. The wholesale price is your cost of the products consumed. **(Do not include the delivery fee or the tax on the delivery fee).**

5. Change in Sales Tax Rates

You pay sales tax based on the suggested retail price of taxable products and the sales tax rate in effect at the time of billing. However, when you make a sale to a customer or another independent business owner, you must charge the rate of sales tax in effect at the time of the sale.

If the rate of sales tax is different than that which you were charged, you must submit an Adjustment Form with section two completed.

- **If the rate is higher:** Send a check payable to Sales Tax Department for the additional sales tax collected along with the Adjustment Form.

- **If the rate is lower:** File the Adjustment Form with section two completed, requesting a refund of the difference between the sales tax paid and the amount collected.

When requesting an adjustment of the tax on your entire inventory, please include an itemized list of the inventory at the time of the rate change including quantities, product numbers, descriptions, and suggested retail price.

Summary

All “Sales Tax Adjustment Form” applications must contain sufficient information to clearly identify the reason for the refund request. The forms must also be signed by the independent business owner claiming the refund and include a telephone number, area code and the period covered by the claim.

Independent business owners may file Adjustment Forms monthly, quarterly, or annually. It is suggested that you determine how often you file by the amount of sales tax due or refundable; however, you must file at least annually. If your period covered had a rate change during this time, you will need a form for each period at each rate.

Please use actual numbers. Do not round off or estimate amounts. Any overage or shortage paid with your order will be included in the I.B.O. Summary and Bonus.

Do Not Obtain a Sales Tax License for your business. All independent business owners are operating their business under the sales tax license that this corporation has obtained, per our agreements with the states, counties, and cities. If at any time you need the verification of that license number, please contact the Tax Department.

Sales Tax Certificates of Exemption required for tax-exempt orders:

Effective May 3, 2004, the Sales Tax Exemption Program (STEP) launched. The STEP program requires that an IBO, Member, or Client have a sales tax exemption certificate on file prior to placing an order for tax-exempt sales. No order will be shipped without the application of sales tax unless a sales tax exemption certificate has been completed by the customer and placed on file with the Quixtar Sales Tax Department by the IBO, Member or client prior to placing an order.

You must complete a sales tax exemption form for each of your tax-exempt customers. The applicable sales tax exemption form is available on www.quixtar.com in the Tax info section. The exemption form must be completed by the customer claiming exemption. To assist in timely processing, please be sure the date, name, signature, IMC number, reason code, and description has been completed prior to submitting the document.

The ability to place orders without sales tax, once a certificate is on file, is currently only available for telephone orders, but we anticipate having this feature available on www.quixtar.com by mid September 2004.

Please note there will be a 48-hour turnaround time in getting the Sales Tax Certificate of Exemption into our computer system, so please plan ahead. Our Sales Tax Department staff is available Monday-Friday, 7:30 a.m. – 4:30 a.m. ET. If you prefer not to wait to place your tax-exempt order, place the order with the tax included, then make an application to our Quixtar Sales Tax Department for refund of the sales tax by filing the Quixtar Sales Tax Adjustment Form and attach the applicable sales tax exemption certificates.

Note: Orders for tax-exempt customers should be placed separately and not combined with orders for taxable customers or personal use items.

Other Taxes:

Washington:

- a) Retail Business & Occupation Tax--collected by Sales Tax Dept.
- b) Wholesale Business & Occupation Tax--collected by Sales Tax Dept
- c) City Business & Occupation Tax--not collected by Sales Tax Dept.
(Independent business owner must register with the city and pay the city.)

West Virginia:

- a) Business Franchise Certificate (Independent business owner must register with the state.)

Virginia: Annual Litter Tax (Independent business owner must register with the state and pay the state.)

Other States: Additional Taxes in Some States include Soft Drink Tax, Litter Tax, Oil Tax, Hard-to Dispose Material Tax. Some of these taxes are collected by this Corporation at the time of the sale of the products to the independent business owner and remitted to the applicable states. Contact the Tax Department for additional information.

Municipal Business Licenses:

Many local governments require persons to register and sometimes pay an annual fee for the privilege of doing business in the municipality. If you are contacted by a governmental entity regarding a business license, ask for a copy of the ordinance. If it is not clear, send it to the Legal Division who will determine if the law applies to you. If you follow the Sales and Marketing Plan in developing your business, many ordinances will not apply. In some municipalities, however, independent business owners are required to obtain licenses and pay a nominal fee. In these instances, of course, this Corporation recommends compliance with the law.

Subsequent changes in the law, rules or regulations may change some of the material covered here (e.g., state and local tax rates as well as exemptions change periodically). You should periodically check the “The Loop” (a publication, which is mailed upon request) or “What’s New” (on the web) for updates and contact the Sales Tax Department for the most current information.

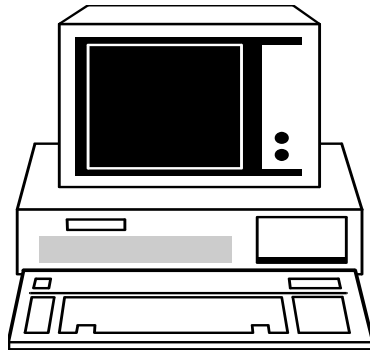
