**STIPULATION AND ORDER
TO EXTEND CASE MANAGEMENT ORDER DEADLINES**

Plaintiff Team of Destiny, Inc., by its attorneys, Kuiper Orlebeke PC, and Defendant Scott A. Larsen, by his attorneys, Butzel Long, PC, hereby stipulate and agree to an extension of the dates in the case management order. The period of extension reflects the period of time that the parties participated in voluntary facilitative mediation, during which time the parties did not pursue discovery and stayed answering discovery that would otherwise have been due. 
facilitative mediation process, and by informal agreement, to stay discovery, until February 11, 2005.

Accordingly, the parties request that the following dates govern the pendency of this case, which reflect an extension of time from the case management order.


- Discovery cut off: July 31, 2005




